Auto <ul style="list-style-type: none"> • Payment • Insurance 	\$800 \$300	Proof of vehicle ownership required. One month's worth of payment. Payment for penalties or late fees not allowed.
Books/School Supplies/ Tools/Technology Equipment/ Software	\$1,000	A list of items required for training or employment must be provided by the training provider or employer. Items that may be necessary for the participant to complete training or to become employed may also be considered. May include product warranty and costs associated with shipping and handling.
Certificates/Licensing/Testing/ Fingerprinting/Background Checks/Processing Fees	\$1,000	Documentation indicating the service is a condition of employment is required.
Clothing <ul style="list-style-type: none"> • Work / Interview / Uniforms • Work Shoes 	\$250 \$200	May be in the form of a gift card or reimbursement.
DMV Print Out/ CA Driver License/ID	Per DMV Cost Not to exceed \$100	As needed for employment or job search.
Physical Exam/TB Test/Flu Shots/Vaccinations/Drug Screening	\$150	Documentation indicating the service is a condition of training or employment is required.
Telephone	\$300	Payment for penalties or late fees not allowed. Bill must be in customer's name or provide documentation supporting ownership, may include self-attestation.
Toiletries/Hygiene Products	\$50	May be in the form of a gift card or reimbursement.
